**(Eligibility criteria for admission into D.Pharm and B.Pharm courses in the Institutes of Assam including Private Institutes)**

In continuation of SSUHS Notice regarding eligibility for admission into D.Pharm and B.Pharm courses in Assam in both Govt. and Private Institutes vide No.Janasanyog/D/3501/23 dated 25/05/2023, the University is pleased to notify the minimum eligibility criteria/ cut off score in the Entrance Examination for admission into D.Pharm and B.Pharm courses for academic session 2023-24.

The authorities of institutes running D.Pharm/ B.Pharm courses are requested to admit only those students who fulfil the above minimum eligibility criteria and other criteria as laid down by Pharmacy Council of India in this regard. The Pharmacy Institutes shall submit list of students admitted in academic session 2023-24 to SSUHS along with authenticated copies of score card of CEE-2023 and HS (Science) Marksheet on or before 10<sup>th</sup> November, 2023. The SSUHS will only issue University Registration to the students who fulfil all the above criteria.
