**ADMISSION TO THE MDS COURSE (ASSAM QUOTA) IN  
THE REGIONAL DENTAL COLLEGE, GUWAHATI, FOR THE SESSION 2016**

Applications are invited from the Dental Graduates belonging to the state of Assam for admission to the MDS course (Assam Quota) of Regional Dental College, Guwahati, for the session 2016 for the subjects of (1) Oral & Maxillofacial Surgery and (2) Periodontics. Interested candidates are hereby informed to collect Application Forms by paying Rs. 300.00 (Rupees Three hundred only) in the form of Bank Draft/Banker's Cheque in favour of “**Srimanta Sankaradeva University of Health Sciences**” payable at “**S.B.I., GMC Branch, Guwahati**” from the Office of the Principal, Regional Dental College, Guwahati.

Application Forms will be issued on all working days during office hours from **08-01-2016 to 16-01-2016** from the office of the Principal, Regional Dental College, Guwahati. The last date of submission of filled in Application Form is **18-01-2016 (up to 4:15 PM)** which is to be submitted at the Office of the Principal, Regional Dental College, Guwahati.

Applicants or their duly authorized persons are informed to collect the Admit Cards from the Office of the Principal, Regional Dental College, Guwahati, on **28-01-2016** during office hours.

**The Entrance test will be held on 30-01-2016 from 10AM to 1PM.**

Admission into the courses is subject to the approval by Ministry of Health & F.W., Government of India, and Dental Council of India.

**Important:**

1. An Examination Fee of Rs. 4700.00 (Rupees Four thousand seven hundred only) shall have to be deposited along with Application Form.
2. Modification of the Admission Rule, if any occurs afterwards shall be made public through newspaper.
3. This is for the information of all concerned that Mobile Phones and any other Electronic Gadgets are not allowed inside the Examination Hall. Candidates are requested not to bring any such items to the examination hall, possession of which will make him/her liable for expulsion from the examination. Candidates are also informed that Mobile Phones etc. will not be kept by the staff of the examination centres and shall have to keep them outside the examination hall at their own risk.

ORDER FOR ADMISSION INTO MDS COURSE, ASSAM QUOTA.

In supersession of all earlier orders, the Governor of Assam is pleased to lay down the following procedure to regulate the Admission into MDS Course, Assam Quota, in the Regional Dental College, Guwahati, for Academic Session, 1998-99. Candidates will be selected on the basis of the Admission Test. This procedure shall remain in force till further orders.

1. CONDITIONS FOR ELIGIBILITY FOR APPEARING IN THE ADMISSION TEST/INTERVIEW AS THE CASE MAY BE, FOR SELECTION AND ADMISSION TO THE MDS COURSE.

- (a) A candidate must be a citizen of India and his/her parents must be a permanent resident of Assam.
- (b) A candidate must have obtained the degree of Bachelor of Dental Surgery (BDS) from the Gauhati University or from any other University as recognised by the Gauhati University and the Dental Council of India.

Such candidates must have completed one year Compulsory Rotating Internship, in a recognised Dental Institution, after being qualified in the Final BDS Examination and the BDS Degree is registered under the Assam State Dental Council constituted under the Dentists Act, 1948, as amended up-to-date.

However, one year Compulsory Internship shall not be applicable to the candidates, who qualified in the BDS Examination prior to 1989.

2. SCHEME OF SELECTION:

- (a) There shall be a Selection Board for the purpose/process of selection of candidates for admission into the Post Graduate Course (MDS) under the Rules consisting of the following.
  1. Director of Medical Education, Assam : Chairman
  2. Deputy Secretary to the Government of Assam: Member.  
Health & Family Welfare(B) Department.
  3. Principal, Regional Dental College, Guwahati-32: Member

- (b) Selection of the candidate shall strictly be made on merit of a candidate on the basis of the result of the Admission Test.
- (c) The merit of the candidates shall be ascertained by an Admission Test. In case, due to certain unforeseen reason, such admission test can not be held, in such circumstances the merit of the candidates shall be ascertained from their academic records on the basis of the marks obtained in four BDS professional examinations.
- (d) There shall be no reservation for any category of candidates in view of the fact that number of seats are very limited.

3. ADMISSION TEST FOR MDS COURSE :

- (a) The Admission Test shall be conducted by the affiliating University or any other authority as recommended by the Government.
- (b) There shall be one written paper in such Admission Test bearing one hundred fifty questions (MCQ), each question having four marks. The 150 questions (MCQ) shall cover all the subjects in BDS Course including basic medical subjects. While the positive answer shall entitle the candidate four marks in each MCQ, the wrong answer shall make to lose one mark for every answer. The candidates shall be allowed 3 hours time in such test.
- (c) The admission test shall be of the BDS standard and the syllabus shall be the same as adopted for the BDS Course by the Gauhati University from time to time.
- (d) This admission Rules of 1998 shall remain operative during the coming Sessions, unless otherwise amended/discontinued.

4. MISCELLANEOUS :

Every selected candidate shall execute a bond in Non-Judicial Stamp Paper of ₹ 10/- (Rupees ten only) denomination binding himself/herself to serve in the State of Assam as per the directions of the Govt. at least for 5 years after the successful completion of the Course.
