**ADMISSION INTO 1ST YEAR B.H.M.S. COURSE FOR SESSION 2015
IN HOMOEOPATHIC MEDICAL COLLEGES IN ASSAM**

Applications are invited from interested candidates for admission into 1st year B.H.M.S. Course for session 2015-16 in the Homoeopathic Medical Colleges in Assam and Application Forms will be available at the Offices of Principal, Gauhati Medical College, Guwahati, Assam Medical College, Dibrugarh, Silchar Medical College, Silchar, Jorhat Medical College, Jorhat, FAA Medical College, Barpeta and Tezpur Medical College, Tezpur from **4th August, 2015 to 10th August, 2015** on payment of Rs. 50/- (Rupees Fifty only) in the form of Banker's Cheque/Bank Draft drawn in favour of 'Srimanta Sankaradeva University of Health Sciences' payable at 'SBI, Gauhati Medical College Branch'. The last date for submission of Application Form is 12th August, 2015 (4PM).

The filled in Application Form along with all enclosures and a Banker's Cheque/Bank Draft of Rs. 1000/- (Rupees One thousand only) drawn in favour of 'Srimanta Sankaradeva University of Health Sciences' payable at 'SBI, Gauhati Medical College Branch' is to be submitted within the last date at the Offices of Principal of any of these Medical Colleges of Assam.

An Entrance Examination for selection of the candidates for admission into 1st year B.H.M.S. Course for the session 2015 in the Homoeopathic Medical Colleges of Assam is going to be held in Gauhati Medical College, Guwahati, Assam Medical College, Dibrugarh, Silchar Medical College, Silchar, Jorhat Medical College, Jorhat, FAA Medical College, Barpeta and Tezpur Medical College, Tezpur on **29th and 30th August, 2015**, details of which including eligibility criteria and requirements will be available at the University website, www.ssuhs.in.

Candidate / Person duly authorized by the candidate will be able to collect Admit Cards from the Office of Principal, Gauhati Medical College, Guwahati, Assam Medical College, Dibrugarh, Silchar Medical College, Silchar, Jorhat Medical College, Jorhat, FAA Medical College, Barpeta and Tezpur Medical College, Tezpur on 27th August, 2015 during office hours. Admit cards for the Entrance Examination shall be available to candidates only at the Medical College where he/she has chosen as Examination Centre.

Entrance Examination for Selection of Candidates for Admission into 1st year BHMS Course for the session 2015 in all the 3 (three) Homoeopathic Medical Colleges of Assam

1. An Entrance Examination shall be held on 29th and 30th August, 2015 in Gauhati Medical College, Guwahati, Assam Medical College, Dibrugarh, Silchar Medical College, Silchar, Jorhat Medical College, Jorhat, FAA Medical College, Barpeta and Tezpur Medical College, Tezpur for selection of candidates for admission into 1st year BHMS Course for the session 2015 in all the 3 (three) Homoeopathic Medical Colleges of Assam which will be conducted by Srimanta Sankaradeva University of Health Sciences.
2. The Examination shall be for 300 marks.
3. There will be 100 questions for each subject with 1 mark for each question. There shall be no negative marking for wrong answers. Unanswered questions shall be awarded zero marks.
4. There will be 3 (three) papers as shown below :

Paper-1	-	Physics	-	11AM to 1PM (29 th August, 2015, Saturday)
Paper-2	-	Chemistry	-	2PM to 4PM (29 th August, 2015, Saturday)
Paper-3	-	Biology	-	11AM to 1PM (30 th August, 2015, Sunday)
5. The question papers shall be on the basis of the syllabus of the Higher Secondary School Leaving Certificate Examination (Science Stream) conducted by the Assam Higher Secondary Education Council. Each paper of Physics, Chemistry and Biology shall consist of 100 Multiple Choice questions. The Biology Paper shall consist of 50 questions from Botany and 50 questions from Zoology.
6. If two or more candidates secure same mark in the Entrance Examination the *inter se* merit of such candidates shall be determined in order of preference as follows :-
 - (i) Candidates securing more marks in Biology in the Entrance Examination
 - (ii) Candidates securing more marks in Chemistry in the Entrance Examination
 - (iii) If it further tallies then marks obtained in Biology of qualifying examination shall be considered at the time of counseling.
 - (iv) If it further tallies then marks obtained in Chemistry of qualifying examination shall be considered at the time of counseling.
 - (v) If it further tallies then marks obtained in Physics of qualifying examination shall be considered at the time of counseling.

(I) **Eligibility criteria for admission into 1st year BHMS Course for the session 2015 in all the 3 (three)**

Homoeopathic Medical Colleges of Assam :

1. **Educational qualification :** The candidate must have passed Higher Secondary (Science 10 + 2) or Equivalent Examination with Physics, Chemistry, Biology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination from a recognized Board/Council/University, in respect of candidates belonging to General Category and 40% marks in respect of candidates belonging SC/ST(P)/ST(H)/OBC/MOBC category.
2. **Age :** The candidate must not be below 17years and above 24 years of age on 31-12-2015. The upper age limit will be relaxed for 3 (three) years in respect of candidates belonging to SC/ST(P)/ST(H)/OBC/MOBC category.
3. The candidate must be a Permanent Resident of Assam.
4. **Reservation of seats :-** There shall be reservation of seats for SC, ST(P), ST(H), OBC/MOBC, PH, TGL/Ex-TGL, Martyr's Quota, Char Area Quota, Ex-serviceman Quota, Teacher/Ex-teacher Quota and Freedom Fighter's Quota from the available seats as per Govt. Rule.
5. A candidate who desires to be considered under reserved category shall have to furnish certificates of the concerned category from the competent authority.
6. A candidate applying under Physically Handicapped category shall have to produce identity certificate from the State Level Medical Board/District Level Medical Board as constituted in pursuance of Social Welfare Deptt.'s notification No. SWD.181/96/75, dated 21-06-1990. The Medical board shall have to follow the instructions and working principles for issuance of Physically Handicapped certificates to disabled person as issued by the Social Welfare Deptt. O.M. No. SWD.181/36/65, dated 31-03-1999.
7. In case of candidate applying under Char Area category, the candidate must produce the certificate from competent authority i.e. from the Char Area Development Authority and countersigned by the concerned Deputy Commissioner/Sub-Divisional Officer certifying that the area where the candidate generally resides is covered by the Char Area Development Authority of Assam and that his/her parents are from socially, economically and educationally backward family ordinarily residing in the area and not entitled to any other form of reservation, and also that the names of his /her parents are enrolled in the voter list of their respective Char Area village.
8. A candidate applying under TGL/Ex-TGL category shall have to produce certificate from the concerned Deputy Commissioner/Sub-Divisional Officer and countersigned by the Director of Tea Welfare, Govt. of Assam.

9. In case of candidate applying under Freedom Fighter's Quota, the candidate must produce the certificate from competent authority, i.e. Principal Private Secretary to the Chief Minister of Assam and a relation certificate of the candidate with the Freedom Fighter from the concerned Deputy Commissioner of the District.
10. A candidate applying under Teacher/Ex-teacher category must be a son/daughter of a teacher/ex-teacher of Homoeopathic Medical College of Assam and have to produce relation certificate from the concerned Principal and countersigned by the Director of AYUSH or his authorized official.
11. Martyrs Quota and Ex-serviceman Quota shall be as per criteria laid down by the Government of Assam.

IMPORTANT : It is the responsibility of the applicant to furnish all information correctly. Any information given by the applicant if found to be false or any ineligibility criteria detected at any stage later on shall make him/her disqualified from the entrance examination with all its associated consequences.

- Please do not apply if you are not eligible for the Entrance Examination.
