NOTIFICATION

The 22nd December, 2006

No. HLB 514/2006/26: In supersession of the Assam Medical Colleges (Regulation of admission to Post Graduate Courses) Rules, 2004, except as respects the things done or omitted to be done before such supersession, the Governor of Assam is hereby pleased to make the following rules, namely:-

1. SHORT TITLE, COMMENCEMENT AND APPLICATION-

(1) These rules may be called the Assam Medical Colleges (Regulation of Admission to Post-Graduate Courses) Rules, 2006.

(2) They shall be deemed to have come into force on the date of their publication in the Official Gazette. rules and shall also cover the academic session from 2007 in respect of admission to Post-Graduate Courses.

(3) They shall apply to all the seats available in all the three Medical Colleges of Assam in all disciplines for the Post-Graduate Degree and Diploma courses.

2. DEFINITION-

In these rules unless the context otherwise requires,

- (i) "Board" means a Selection Board constituted under rule 7;
- (ii) "Commission" means Assam Public Service Commission;
- (iii) "Council" means the Medical Council of India;
- (iv) "Entrance Examination" means a competitive examination conducted among the candidates by the Gauhati University or any other competent authority as may be decided by the Government from time to time for admission to the Post-Graduate Degree/Diploma courses of the Medical Colleges of Assam;
- (v) "Government" means the Government of Assam;
- (vi) "Post-Graduate Courses" means Post-Graduate Degree or Diploma courses of the Medical Colleges of Assam as approved by the Medical Council of India;
- (vii) "OBC/MOBC" means Other Backward Classes and More Other Backward Classes as notified by the Government by an order which is in force on the date of advertisement calling applications for admission to Post-Graduate Courses;
- (viii) "Schedule Castes" means Scheduled Castes as notified by the President of India by order which is in force on the date of advertisement calling applications for admission to Post-Graduate Courses;
- (ix) "Scheduled Tribes" means Scheduled Tribes notified by the President of India by order which is in force on the date of advertisement calling applications for admission to Post-Graduate Courses.

3. COURSES AND SEATS-

(1) **NUMBER OF SEATS:-** On the date of commencement of these rules, the number of total seats in the Post-Graduate Courses in different disciplines and their break up are shown in Appendix-I.

Provided that the number of such seats shall be determined by the Government from time to time with the approval of the Medical Council of India. The total number of such seats shall be notified before counselling for admission into the Post Graduate Courses.

(2) DURATION OF COURSES-

(a) The Post-Graduate Degree Courses shall be 3 years and that of the Post-Graduate Diploma Courses shall be 2 years from the date of their respective admission.

(b) The 1st year of the Degree and Diploma Courses shall be utilized for practical training as Junior Residents and continuation of a candidate after one year in the P.G. Courses shall depend on his satisfactory performance as Junior Resident.

4. QUOTA/RESERVATION OF SEATS-

The following Quota/Reservation of seats shall be applicable in respect of admission to the Post Graduate Courses:-

(1) **All India Quota Seats: 50%** of the total seats as referred to in rule 3 shall be reserved for the candidates recommended by the Government of India selected on the

basis of All India Entrance Examination in each session (Details of these seats, subject, number, college etc. are shown in Appendix-I).

(2) N.E.C. Quota Seats: One seat in Degree and one seat in Diploma course shall be reserved for the candidates for North Eastern States except Assam in each session. The candidates from North Eastern States except Assam shall have to appear in the Entrance Examination conducted by Gauhati University or any other competent authority as may be decided by the Government from time to time and the selection shall be made amongst them in order of merit in the Entrance Examination. Secretary, North Eastern Council (N.E.C.) shall recommend the candidates in the application form and issue certificate in this regard.

(3) Teachers Quota seats: (i) Five seats in Degree Courses shall be reserved for the teachers belonging to the three Medical Colleges of Assam in each session in the subjects of ANATOMY, PHYSIOLOGY, BIOCHEMISTRY, PHARMACOLOGY, MICROBIOLOGY, SPM AND FORENSIC MEDICINE from the session 2007 onwards. However for the teachers who have joined service after APSC regularisation prior to the commencement of these rules shall be eligible for making application for allotment of teachers quota seats in the subjects where they are already working.

(ii) For the purpose of allotment of the teachers quota seats the Joint Director of Medical Education, Assam-cum-Member Secretary of Selection Board shall invite applications from the teachers belonging to the three Medical Colleges of Assam through their respective Principals before starting the selection process for the

session. The selection of the candidates from the applications for the seats reserved under this Quota shall be made by a Selection Board consisting of the three Principals of the three Medical Colleges of Assam as Member and Director of Medical Education, Assam as the Chairman and the Joint Director of Medical Education, Assam as Member Secretary, on the basis of seniority-cum-merit. The interse seniority of the candidates shall be determined as per APSC nomination and Govt. rule in this regard. The interse-merit of the candidates under this quota shall be judged on the basis of percentage of marks obtained in all the three MBBS Examinations and in case of equal marks, marks of Final MBBS shall be considered for interse merit and in case of equal marks of Final MBBS marks of Second MBBS shall be considered.

(iii) A teacher once admitted in a seat under Teachers Quota in a particular session in a particular subject must complete the course and in no circumstances he/she shall be eligible to apply again in a different session in any subject under teachers quota.

(iv) The teacher applying for seats under this quota shall execute a registered Bond for Rs.10.00 lakhs in the format as Appendix-II indicating that on completion of the Post Graduate Courses he/she shall be bound to serve the State Government for at least ten years.

(v) The teachers shall be eligible to apply only in the subject where they are working and for which they have been selected by APSC. Further teachers working in superspeciality departments shall only be able to apply for seats in the broad speciality (Medicine and Surgery) to which

their subject is allied.

(vi) Only one seat in a subject shall be allowed in each session for teachers quota.

(4) State Health Services Quota Seats:

(i) **16 (sixteen) seats (six in Degree and 10 Diploma)shall be reserved in each session for the doctors appointed in the State Health Services on the regular basis on the recommendation of the Commission and who have completed five years or more service in rural areas. The allotment of seats have been shown in Appendix-I**

(ii) The Selection of the candidates under this quota shall be made on the basis of their merit amongst them in the Entrance Examination conducted for this purpose. However they shall be eligible to compete for other seats as per their merit position.

(iii) The doctors applying for seats under this quota shall have to submit the application form through their respective controlling officer i.c. DHS/DHS(FW)/Jt. DHS with a certificate issued by the Controlling Officer. **The term rural area shall denote an area which is not a notified urban / town area and shall be situated at a minimum distance of 5 km from such notified urban area and town area and five km beyond the nearest point of national highway.**

(iv) There shall be no reservation of any kind among seats under the State Health Service quota. Merit in the Entrance Examination shall be the only criteria for selection for this quota.

(v) The doctors applying for seats under the State Health

Service Quota shall execute a Registered Bond for Rs. 10.00 lakhs (Rupees Ten lakhs) in the format as Appendix-II indicating that on completion of the Post Graduate courses he/she shall be bound to serve the State Government for at least 10 years.

(5) Reservation for Scheduled Castes, Scheduled Tribes and OBC & MOBC: Following percentage of the seats available shall be reserved for Scheduled Castes, Scheduled Tribes and OBC/MOBC candidates in each session:-

- (i) S.C. - 7%
- (ii) S.T(P) - 10%
- (iii) ST(H) - 5%
- (iv) OBC/MOBC - 15%

(details shown on appendix I)

(6) Pool: (i) The following number of seats shall be pool seats to be rotated between different candidates in every session by the Selection Board serially (details in Appendix-I) and shall be filled up according to merit.

5. ENTRANCE EXAMINATION AND PREPARATION OF MERIT LIST-

(A) APPLICATION -

(i) The candidates shall have to apply in the prescribed form duly filled as per instructions given in the form and submit the same to the Principals of Medical Colleges of the State.

(ii) All applicants shall have to give Attested copies of the following documents along with their application forms.

1. Admit card of HSLC & HSSLC examinations
2. All marksheets
3. Internship completion certificate
4. Permanent Registration certificate of State Medical Council / Medical Council of India
5. Caste certificate
6. Permanent Resident Certificate of Assam wherever applicable.

(B) PHOTOGRAPH -

(i) Each candidate shall submit a coloured digital passport sized photograph / coloured standard photograph

(ii) 4 copies of photograph have to be submitted of which 1 copy shall be pasted in the form (not stapled), 1 copy in the admit card and 2 copies shall be spare. The spare copies shall be sealed in a transparent envelope, which shall be stapled to the form.

(iii) The 4 copies of the photographs submitted shall be the same.

(iv) The photograph should show the name of the candidate as well as date of photograph taken or on a placard held by the candidate in front of the chest.

(v). Mixture of different photographs or submission of Black and White photographs shall not be acceptable and such act may make the form liable to be rejected.

5 (C) ADMIT CARD-

(i) The format of the admit card given along with the form shall be filled up by the candidates in his/her own handwriting.

(ii) The admit card filled up by the candidate shall be scanned along with the photograph and two copies shall be made. One copy shall be given to the candidate and one copy shall be sent to the center where the candidate shall appear in the exam for verification at the center. The original shall remain with the form.

(iii) The forms and admit cards shall be numbered and both shall bear the same number.

(iv) SIGNATURE: The candidate shall affix only full signature in the form and admit card and shall have to write his name in capital letter also. The signatures should be uniform in all connected documents of Entrance Examinations.

(v) PHYSICAL MARKS: In the admit card, under the place for photograph there shall be space for listing two identifiable physical marks such as scars, moles etc which would help in establishing the identity of the candidates.

The candidate shall list the two identifying physical marks in the space provided in the admit card and also in the form.

(vi) The candidate shall have to sign on his/her copy of admit card in the examination hall before the invigilator during the exam. During entry to the examination hall the student has to sign on the centre copy of the admit card.

This card shall have water mark.

The candidate must bring candidate's copy of admit card to counselling without fail.

5 (D) EXAMINATION-

(i) An Entrance Examination shall be conducted for the purpose of admission to the Post-Graduate Courses in the Medical Colleges of Assam by the Gauhati University or any other competent authority as may be decided by the Government from time to time.

(ii) All candidates except those selected for All India Quota seats and Teachers Quota seats, shall have to appear in it.

(iii) The Examination shall be conducted in Guwahati on such date and in such venue/venues as may be decided by the Gauhati University or any other competent authority entrusted by the Government to conduct the examination as per provision of Medical Council of India guide lines.

(iv) There shall be one single paper of 3½ hour duration giving weightage as under: (The figures within bracket

shows the tentative number of questions in each subjects)

(a) Basis Sciences (Anatomy-10, Physiology-10, Biochemistry-15, Pharmacology-15, SPM-15 & Forensic Medicine-10) – 25%

(b) (Pathology-30, Microbiology-20, Radiology-15, Genetics-5, Immunology-5)- 25%

(c) (Medicine-45, Surgery-30, Obst. & Gynae-20, Paediatrics-20, Ophthalmology-15, E.N.T. & Orthopaedics-20) -50%

(v) There shall be total 300 questions with I mark for each question. The question shall be multiple choice, objective type and shall carry I mark for correct answer. In case of there being more than one correct answer in a multiple choice question the I mark shall be divided into equal fraction for each correct answer. The question paper shall indicate clearly the marking in respect of questions having more than one answer. There shall be no negative marking for wrong answer and unanswered question. There shall be multiple sets (minimum 5 sets) for each question paper, each set containing same 300 questions in different sequence.

(vi) A candidate shall have to secure at least 50% marks in case of general candidates and 40% in case of SC, ST(P), ST(H) & OBC/MOBC respectively in the Entrance Examination to be eligible for admission to the Post Graduate Courses. This shall also be applicable for candidates under State Health Service quota i.e. 50 % marks for general candidates and 40 % marks for Reserved Categories.

(vii) A Central committee shall be constituted to oversee the conduct of examination. The committee shall consist of

1. Officer in charge of the organization entrusted to conduct the examination.

2. Controller of examination of DME office.

3. Principal of Gauhati Medical College

(viii) Examination venue shall be at Guwahati and shall be at a Government premise or at an institution where security can be maintained. The district civil and police administration are also to be involved.

(ix) Center Examination Committee – There shall be a center committee and it shall be constituted with addition of a representative of district civil administration and faculty of university or medical colleges. The committee shall oversee verification of admit card in the center.

(x) All candidates shall be present at the examination center two hours before time along with their copy of admit card.

(xi) In the center their admit cards shall be compared with the admit card available at the center and after verification, the candidates shall be allowed entry to the hall proper. The candidate shall have to affix his signature again in the Admit Card copy kept in the centre.

(xii) A slip with room no. and seat no. shall be given to them.

(xiii) No mobile phones or any other electronic items shall be allowed inside the hall. Presence of such items shall make the candidate liable for disqualification.

(xiv) The candidate shall also affix his/her signature on the copy of the admit card supplied to the candidate before the invigilator in the examination.

(xv) After the examination is over, the answer scripts shall immediately be placed in sealed packet and shall be kept for safe keeping on the day after the exams are over, the sealed packets shall be transported under escort to a predesignated strong room.

5(E) SCRIPT EVALUATION-

(i) Script evaluation shall be done by computerized optical method

(ii) Ideally the script evaluation by the above method should be done in a government set up or in a reputed Institution or any other suitable agency - where total security can be maintained.

(iii) The Central committee constituted by the Govt of Assam (as per clause 5 (D)vii) to supervise the procedure shall also be responsible for results, but two new members may be brought in at this stage to facilitate computer work. They shall be -

1. Computer expert from IIT / Govt. of Assam - Dept. of IT/University Dept. of Computer Science.
2. Expert from evaluation agency - wherever necessary.

5.(F) MERIT LIST-

(i) The Gauhati University or the authority appointed by the Government from time to time for the purpose of conducting the Entrance Examination shall after examining the candidates prepare a merit list on the basis of total marks obtained in the Entrance Examination by the candidates in descending order and taking into consideration the other provisions under this rule as hereinafter provided.

(ii) The merit list shall be the basis of selection for different categories of seats for Post-Graduate Courses.

(iii) In the event of two or more candidates securing equal marks in the Entrance Examination, the merit amongst them shall be decided on the basis of percentage of marks obtained by each of them in all the three MBBS examinations.

Provided that in the event two or more candidates securing equal percentage of marks in the three MBBS examinations, their interse merit shall be decided on the basis of the percentage of marks obtained by them in the Final MBBS examination. If it further talleys then marks of Second MBBS Examination shall be considered.

5.(G) DECLARATION OF RESULTS THROUGH WEBSITE-

i) Once the results are finalized, first they shall be declared through website. A website shall be designed and erected for this purpose.

Only after declaration through website, hard printed

copies shall be printed and released.

6. ELIGIBILITY FOR ENTRANCE EXAMINATION-

For appearing in the entrance examination, a candidate must –

- (i) be a citizen of India.
- (ii) be a permanent resident of Assam and must furnish a certificate to this effect.
- (iii) have MBBS degree from a Medical College of Assam /University of the State of Assam recognized by the Medical Council of India.
- (iv) have permanent registration with State Medical Council or Medical Council of India, and he has not been undergoing a Post-Graduate Degree/Diploma course in any Medical Colleges at the time of application and who shall submit an undertaking in this regard. However candidates who is unable to submit Permanent Registration Certificate at the time of application shall also be eligible but he / she must submit the same at the time of counseling.
- (v) the provision of Permanent Resident Certificate shall not be applicable to the wife/husband/sons/daughters of the employees of the Government of Assam and students admitted under 15% all India quota seats in MBBS in the Medical Colleges of Assam.

7. SELECTION BOARD AND SELECTION PROCESS –

- (1) **Constitution of Selection Board:** There shall be a Selection Board for the purpose of selection of candidates

for admission into the Post-Graduate Courses under these rules consisting of the following:-

- (a) Director of Medical Education, Assam,
Chairman
- (b) Principal, Assam Medical College, Dibrugarh-
Member
- (c) Principal, Gauhati Medical College, Guwahati-
Member
- (d) Principal, Silchar Medical College, Silchar -
Member
- (e) Director of Health Services, Assam - Member
- (f) Controller of Examination, (DME office) -
Member
- (g) Joint Director of Medical Education, Assam -
Member Secretary.

(2) Counselling :

- (a) Selection to fill up the seats other than the All India Quota and Teachers Quota seats shall be made by holding a counseling on the date and place notified by the Chairman of the Board.
- (b) Candidates whose names appear in the merit list shall be called in the counseling serially before the Board in order of merit to produce original documents/testimonials for verification by the Selection Board.
- (c) The Board on being satisfied with documents and certificates so produced by the candidates shall seek their choice of subject/college.

(d) A candidate shall be allotted a seat in the subject and in the college of his / her choice by the Board in accordance with his/her position in the merit list.

Provided that the Board may not allow the choice given by any candidate for reasons to be recorded in writing in the minutes of the Selection Board.

(e) A candidate belonging to SC/ST(P)/ST(H) and OBC/MOBC can opt for General open seats in any subject/college if such a seat is available according to their position in the merit list or they may opt for any reserved seat of their own category that is available.

(f) Conversion formula in case of candidate belonging to the reserved category opting for a reserved seat in general merit position.

If a candidate belonging to ST(P), ST(H), SC and OBC / MOBC reserved categories opt for a reserved seat from General merit position in a subject and college of their choice, the said seat shall be considered to be dereserved and shall be brought to the General category to accommodate the candidates.

After doing so, a general seat in the same subject shall be brought under reservation in the same category to which the candidate belongs.

If a seat in the same subject is not available, then a seat in the subject in the broad stream of medical specialities / subjects or surgical specialities / subjects to which the original seat belonged shall be so reserved.

If no such seat is available even in the broad Medical or Surgical Specialities, then the Board may decide to reserve any subject in any college.

This formula is adopted to keep the total number of seats belonging to a particular reserved category constant as per the judgement of Honourable Gauhati High Court in W.P.(C) NO. 1431/97.

(g) In case of doubtful cases the Selection Board shall refer the cases to the competent authority or to the State Forensic Laboratory.

(3) The candidate shall be physically present in the counseling.

(4) The candidates shall show the following original documents during admission:-

(a) HSLC Admit Card/HSLC Pass Certificate.

(b) Mark sheets of HSSLC (10+2) and all MBBS Examinations.

(c) Internship Completion Certificate.

(d) Permanent Residency Certificate.

(e) Caste Certificate

(f) Permanent Registration Certificate of State Medical Council / Medical Council of India.

Provided that the wife/husband/sons and daughters of the employees of Govt. of Assam as referred to in rule 6(v) shall produce a certificate from the concerned departmental authority to the effect that he/she is the

husband/wife or son/daughter of the employee of the particular category. Further, the candidates who have passed the MBBS course in Assam under 15% All India quota shall produce a certificate from the respective Principal to that effect.

(5) If a candidate is absent in the counseling the Board shall not allow any seat to him/her.

(6) The candidate shall sign on the acceptance slip stating the subject/college in the Post Graduate Courses allotted to him expressing his acceptance or non-acceptance of the same and deliver it to the Member Secretary of the Board.

(7) Each category of candidates shall be called for counseling in the following order:-

(1) General or open (unreserved), (2) N.E.C. Quota, (3) Reserved Quota, (4) State Health Services Quota.

(8) All the selected candidates shall take spot admission in the day of counseling.

(9) No second counseling shall ordinarily be held.

(10) The candidates shall be required to deposit an amount of Rs. 250/- (Rupees two hundred fifty) only as counselling fees in cash to the Director of Medical Education, Assam, at the time of counselling. The Director of Medical Education, Assam shall utilise the amount so collected as counselling fees in conduct of Admission procedures, provided he shall be required to submit the expenditure statement alongwith utilisation certificate to the Government for approval.

8. ADMISSION-

- a) The candidates must take admission on the stipulated date, otherwise their allotment shall be cancelled.
- b) During admission each candidate **including All India quota candidates** have to deposit the following documents in original. The documents shall remain in the safe custody of the Principal till the completion of the course and shall be returned to the candidate only after obtaining Hostel/Mess/Library clearance certificate at the completion of the course.
- c) Certificate to be deposited at the time of admission in original.
- (i) HSLC Admit Card/HSLC Pass Certificate
 - (ii) Mark sheets of HSSLC (10+2) and all MBBS Examinations.
 - (iii) Internship Completion Certificate.
 - (iv) Permanent Registration Certificate of State Medical Council or Medical Council of India.
 - (v) Permanent Residency Certificate (wherever applicable).
 - (vi) Caste Certificate issued by the competent authority.
- d) If a candidate including All India quota candidates resigns from a particular course at any time and the resignation is accepted on fulfillment of the provision of these rules, the certificates may be returned to the candidates. The provisions of Rule 9 (1) and 9 (2) and 9 (3) shall also be applicable to them.

(e) If the certificates are required by the candidate for appearing in an interview for employment, the same can be given to him/her on application with copy of the call letter of the interview only in the last six months before completion of the particular Degree / Diploma course. The original must be returned to the Principal on return from interview.

9. RESIGNATION FROM A SESSION/SURRENDERING OF A SEAT-

In case a candidate including an All India Quota Candidate resigns from a particular session after admission and he/she applies for allotment of seats in subsequent batch, he/she shall

- (1) return the stipend if already drawn to the Principal of the College.
- (2) pay a penalty of Rs. 25,000/- (Rupees twenty five thousand only) by way of Bank Draft payable to the Director of Medical Education, Assam at S.B.I. Guwahati, Dispur Branch.
- (3) be eligible to get back the original certificate deposited with the Principal only on the fulfillment of the provision of sub-rule (1) and (2) above.

10. TRANSFER-

Under no circumstances a candidate once selected and admitted for a particular Degree/Diploma course at a particular College in a particular subject shall be transferred to another course or another college or another

subject as per the Medical Council of India norms. (e)

11. APPEAL—

(i) The Government shall dispose of all appeal if any, received from any candidate aggrieved by the decision of the Board within seven days from the date of its receipt.

(ii) Any candidate aggrieved by the decision of the Board may prefer appeal before the Government within two days of the communication of the Board's decision to him.

(iii) Such appeals shall be addressed to the commissioner and Secretary to the Govt, of Assam, Health & Family welfare Department, Dispur, Guwahati-6.

12. BOND—

After being selected the candidates (under Sub-rule (3) and (4) of rule (4) shall execute a duly registered bond on a non-judicial stamp paper of the value of Rs. 10.00 (Ten) only in the form as appended in Appendix-II for binding himself/herself to serve under the Government of Assam for a period of 10 (Ten) years on completion of the Post Graduate Course and in breach thereof to pay a sum of maximum of Rs. 10,00,000/- (Rupees ten lakhs) only to the Government as compensation and deliver the same to the Government and the candidates other than the candidates under Sub-rule (3) and (4) of rule-4, they shall also execute and furnish a dully registered bond on the non-judicial stamp paper of the same value and in respect of the amount as stated herein above provided their services are required by the Government.

13. MISCELLANEOUS-

- a) Every candidate shall apply in the prescribed form to be issued by Gauhati University or any other competent authority under these rules on payment of such sum as may be notified in the advertisement given for the purpose.
- b) Application must be filled up by the candidate in his/her own handwriting and shall be accompanied by all necessary certificates, documents and fees as may be prescribed in the rules / advertisement. Incomplete application form in any respect shall be rejected and no communication in this regard shall be entertained. The Authority/Institute shall not be responsible for any delay in the receipt or loss of application in postal transit and no correspondence in this regard shall be entertained. Any document/certificate which is found to be false or fabricated at any stage shall make the application liable to rejection and admission if given on basis of such documents/certificates shall be liable to be cancelled without any refund of any fee, etc. paid in this regard and criminal proceedings shall be drawn against such candidate.
- c) No candidate shall after taking admission into a Post-Graduate course be allowed to practice or take up a job-part time or otherwise till the completion of the course.
- d) Every candidate shall have to pass the Final Post-Graduate examination in maximum three attempts.

14. STIPEND-

- (i) The students undergoing Post Graduate Courses except the students from Teachers Quota and State Health

Service quota and others who have received salary from their respective appointment authorities shall be paid a stipend as may be fixed by the Government from time to time.

(ii) The stipend will be paid subject to availability of fund only.

(iii) Students receiving/stipend/scholarship from other sources are not entitled for above stipend.

(iv) Students continuously absent in the course without any information for 3 months from the date of commencement of the classes shall forfeit the seat.

15. REMOVAL OF DIFFICULTIES-

Notwithstanding anything contained in these Rules, the Govt. shall have the power to take any action, not inconsistent with the provisions of these rules, as may be necessary to remove any difficulty for which no express provision exists in these rules.

16. SCHEDULE OF SUBMISSION OF PROTOCOLS, THESIS AND EXAMINATION-

(1) **Protocol:** The candidate pursuing the Post Graduate Course shall work as a full time regular Junior Resident during the first year and submit 2 copies of the Protocol (subject of thesis) and synopsis by 6 months after approval by the Department faculty to the Principal for onward transaction to the University.

- (2) **Thesis:-** In the second year the candidates shall do their thesis work and submit their thesis in part fulfillment of MD/MS degree 6 months before the examination as a full time regular student under guidance of the supervisor.
