- (a) The acceptance of the quotation will rest solely with the Tender inviting authority. The department is not bound to accept the lowest quotation and reserves the right to reject or partially accept any or all the quotations received without assigning any reasons.
- (c) If the supplier fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by the authority, the work order may be terminated
- (d) Authority may terminate the contract / purchase order in whole if the quality requirements not met by the bidder
- (e) Tender authority reserves the right to Add / modify / relax or waive any of the conditions stipulated in the tender document whenever deemed necessary.
- (f) The project needs to be completed within 3 weeks from the award of the contract.

6. Reasonability of rates/ firm price:

- The rate quoted by the bidder should have the validity of 180 days.
- No bidder will be allowed at any time, on any ground whatsoever, to claim revision of or modification in the rates quoted by him. The representation of the bidder that computation/typographical or clerical error etc. has been committed in the bid and request for reversion on such plea shall not be entertained after submission of the bid.
- 7. **Lowest Rate:** The undersigned is not bound to accept the lowest rate and reserve the right to reject or cancel the tender without assigning the reason whatsoever.
- 8. Late and delayed tender: Late and delayed tender will not be considered. In case any unscheduled holiday occurs on the prescribed closing/ opening date the next working day shall be the prescribed date of closing/ opening.

Evaluation procedure

The bid will be evaluated following Quality (80%) cum Cost (20%) based selection (QCBS) method -80:20

The Technical quality of the proposal will be given weightage of 80%. The financial bids of only those bidders who qualify technically (minimum qualifying mark is 50) will be opened. The proposal with lowest cost will be given a financial score of 100 and the other proposal will be given financial score that are inversely proportional to their quoted price. The financial proposal shall be allotted weightage of 20%. For working out combined score, the following formula will be used:

Total points T(p) = T(w) X T(s) + F(w) X F(s), where

 $F(s) = \{(LEC/EC) \times 100 \}$

T (w) = weightage of technical score which is 0.8

T(s) = technical score obtained by the bidder

F (w) = weightage of financial proposal i.e. 0.2

F (s) = Financial score of the financial proposal obtained by the bidder.

LEC= Lowest evaluated cost of the financial proposal.

EC= Evaluated cost of the financial proposal.

The proposals will be ranked in terms of the total points scored. The proposal with the highest total points (H1) will be considered for award of contact and will be called for negotiations, if required. In the event for a tie, the bids with the highest technical score will be rated as the best bid. Beyond that, Authority will decide the matter in its full discretion. The Director, Welfare of Tea Tribes Assam is not bound to accept the lowest rates. The Director, Welfare of Tea Tribes Assam may reject any or all bids without assigning any reason thereof. The decision of the Bid Evaluation Committee (BEC) will be final and binding to all in this regard.

The Authority reserves the right to modify the evaluation process at any time during the bid process.

It is mandatory for the bidder to obtain minimum technical mark of 50 to be technically qualified and for being considered for opening of their Financial Bid and evaluation thereof. However, the bidders who do not meet the eligibility criteria, their bids will not be opened.

Combined Evaluation of Technical and Financial Bid:

1. The Total score of the bidder will be determined as under:

Total Score T(P) = 80 % Technical score T(S)+20 % of Financial score F(S)

- 2. The bid of the bidder who obtains the highest Total Score T(p) will be rated as the best bid. In the event of a tie, the bid with highest Technical score T(s), will be rated as the best bid.
- 3. The Authority will award the contract to the successful bidder whose bid has been determined to be substantially responsive and has been determined as the best bid. The authority shall however not bind itself to accept the best bid or any bid and reserves the right to accept any bid, wholly or in part,
