Viva will carry 40 Marks (20 Marks each for Internal and External Examiner)

Practical Record Book will carry 10 Marks

### Scheme of Examination for Master of Physiotherapy

#### **Theory**

Total Marks = 100

#### **Practical**

One long Case (1 No.) = 40 Marks

Short Case (2 Nos  $\times$  20 marks) = 40 Marks

Viva = 20 Marks (10 Marks each for Internal and External respectively)

It is mandatory to submit dissertation to the SSUHS to be eligible for appearing in the final (4<sup>th</sup> Semester) examination. The thesis shall be adjudicated by one external examiner.

N: B: 1. It may be noted that minimum 75% attendance in theory and 80% in practical is mandatory for the students to be eligible to appear in the semester examinations.

2. All the students from each course have to secure 50% Marks in each of the subjects separately for both Practical and Theory in order to pass the Semester Examination.
