In pursuance of Assam Govt. Notification No.e.MER.488929/19, dated 26-07-2024, SSUHS is pleased to notify the following minimum eligibility percentile and corresponding marks in the Entrance Examinations for admission into course of GNM.

(1) For all categories of candidates of Govt. seats (Seats in Govt. Institutes):

Category	GNM
General (UR/EWS)	30th Percentile = 29 marks
SC/ST/OBC(NCL)/MOBC/ Divyang	20th Percentile = 27 marks

(2) For 50% Management Quota Seats in Private Institutes:

Category	GNM
General (UR/EWS)	20th Percentile = 27 marks
SC/ST/OBC(NCL)/MOBC	18th Percentile = 26 marks
Divyang	15 th Percentile = 25 marks

(3) For the rest of the seats of Private Institutes:

Category	GNM
General (UR/EWS)	18th Percentile = 26 marks
SC/ST/OBC(NCL)/MOBC	15th Percentile = 25 marks
Divyang	15th Percentile = 25 marks
