The result of Entrance Examination for admission into GNM course in both the Govt. and Private Institutes of Assam conducted by Srimanta Sankaradeva University of Health Sciences held on 11-08-2024 is declared and made available in the University website www.ssuhs.in

Candidates are requested to download their score cards by logging into the application portal available in the University website using Login ID and Password created at the time of submission of application form.

Date of counselling for admission shall be notified by the concerned authorities in due course of time.

In pursuance of Assam Govt. Notification No.e.MER.488929/19, dated 26-07-2024, SSUHS is pleased to notify the following minimum eligibility percentile and corresponding marks in the Entrance Examinations for admission into course of GNM.

(1) For all categories of candidates of Govt. seats (Seats in Govt. Institutes):

Category	GNM
General (UR/EWS)	30 th Percentile = 29 marks
SC/ST/OBC(NCL)/MOBC/ Divyang	20 th Percentile = 27 marks

(2) For 50% Management Quota Seats in Private Institutes:

Category	GNM
General (UR/EWS)	20 th Percentile = 27 marks
SC/ST/OBC(NCL)/MOBC	18 th Percentile = 26 marks
Divyang	15 th Percentile = 25 marks

(3) For the rest of the seats of Private Institutes:

Category	GNM
General (UR/EWS)	18 th Percentile = 26 marks
SC/ST/OBC(NCL)/MOBC	15 th Percentile = 25 marks
Divyang	15 th Percentile = 25 marks

All the Institutes/ Colleges of Assam running GNM course are to admit students for academic sessions 2024-25 and 2025-26 in accordance with the above norms. Non-compliance of the above, if detected at any stage, shall invite serious legal consequences.
