Applications in plain paper with supporting testimonials are invited from the eligible graduates in MBBS/BDS / B.Sc. Nursing from any recognized University for admission into Masters of Hospital Management course under the Srimanta Sankaradeva University of Health Sciences. The candidates will have to appear in the interview on 21-03-2025 at the office of the University. All admission shall be strictly on the basis of marks secured in the qualifying examination (MBBS/BDS/B.Sc. Nursing final examination), and marks obtained in interview. The marks of qualifying examination and interview will have 50% weightage each in preparation of merit list.
