It may be noted that the Supervisor must be from same faculty. Further, those who have already submitted their DRC are directed to submit the following documents along with a Provisional Registration fee of Rs.12000/- (Rupees Twelve Thousand only) to be paid in online mode through the payment gateway (Fee Collect) available in the University website www.ssuhs.in. The original copy of E-receipt is to be submitted along with the form within one month from the date of issue of this notification.

Documents to be submitted:

- 1. Institutional Ethical Clearance Certificate in original.
- 2. 6 (six) copies of Synopsis (to be certified by the DRC)
- 3. No Objection Certificate (in original) (if employed).

Further, the candidates are also requested to submit Registration Form & Eligibility Form along with the original copy of **Migration Certificate** to obtain your University Registration No. & Certificate. The University registration fee is to be paid online through the payment gateway (Fee Collect) available in the University website www.ssuhs.in. The original copy of E-receipt is to be submitted along with the form.

The University Registration fee is Rs.15,000/- (Rupees Fifteen Thousand only) for the students migrating from University/Board/Council etc. within the state of Assam & Rs.20,000/- (Rupees Twenty Thousand only) for the students migrating from University/Board/Council etc. outside the state of Assam. Those candidates who are already registered under SSUHS need not register again. However, a copy of Registration Certificate is to be attached with the application form (Annexure – I) available in the Rules for the Award of the Degree of Philosophy (Ph.D.) 2020 (Amended upto 10th July, 2024).
