**(Master of Hospital Management Course under SSUHS)**

**In continuation of the Admission Notice No. SSUHS/194/2023/1538 Dated 26/3/2025,** the eligible graduates from MBBS/BDS/B.Sc. Nursing from any recognized University are invited for walking interview/counselling for admission into Masters of Hospital Management course under the Srimanta Sankaradeva University of Health Sciences. The candidates will have to appear in the interview/Counselling on **20-05-2025** at the office of the University with supporting testimonials. All admission shall be strictly on the basis of marks secured in the qualifying examination (MBBS/BDS/B.Sc. Nursing final examination), and marks obtained in interview. The marks of qualifying examination and interview will have 50 % weightage each in preparation of merit list.

**Details of the course is as follows:**

1. Name of the Course : Master of Hospital Management (MHM)
2. Application Fees : Rs. 2000 /- (Rupees two thousand) only payable online through University website only.
3. Session Starting Date : Date of commencement of class 1<sup>st</sup> week of June'2025.
4. Duration of the course : 2 years (four semester) inclusive of Internship & Dissertation
5. Course Fees : Rs. 65,000 /- ( Rupees sixty-five thousand) only per semester to be paid at the time of admission.
6. Registration & Exam fees : As per rates of PG courses
7. Stipend : There shall be no provision of stipends for the students.

In-service candidates are required to submit NOC from their parent institutions/employer at the time of interview.
