Terms & Conditions :

- Only authorized students of SSUHS can be enrolled in the hostel.
- Transport facility to pick up and drop will be provided by the hostel.
- The hostel authority has to strictly follow the rules and regulations prescribed by the University authority from time to time.
- The hostel authority will have to appoint a full time eligible warden to take all the responsibilities of the hostel and report to the SSUHS authority from time to time.
- Lodging and food will be taken care of by the hostel authority as per MENU provided by SSUHS.
- The warden has to maintain an IN Register and OUT Register for all the students and also a register having all the addresses and contact details of each broader and their parents / guardians, visits of authorized guardians must be monitored without any compromise.
- The hostel authority will have to appoint a cook, security guard, and support staff as per requirement. A Proper 24X7 security facility will be provided to the hostel by the owner.
- Accommodation for one warden will be provided for day-to-day monitoring of student's academic activity and discipline besides the manager/warden of the owner.

- The hostel authority shall provide all basic requirement to each of the boarders like hygienic food, filtered drinking water, power backup, bed, table, chair, racks, newspaper, TV, refrigerator etc.
- The hostel authority has to take proper care of the cleanliness of all the rooms, bathrooms, and other common areas.
- The SSUHS authority shall appoint one or more hostel in-charge from amongst the employee of the university.
- The SSUHS authority will make surprise visits from time to time to check the quality of food and other amenities.
- All payments will be made on a monthly basis on submission of monthly bills to the SSUHS authority. During the vacation food bill will be deducted as per report of the Hostel-in-charge form the final bill.
- The appointment will be for a period of 36 months from the date of signing this agreement. This appointment is liable to be terminated if any of the above-mentioned terms and conditions is not fulfilled by giving a 30-day prior notice. Discontinuation of services is at the complete discretion of both the parties with a prior 30-day notice to one other.
- Hostels within 15 KM radius of SSUHS shall be given weightage.
- The undersigned has every right to accept and reject the quotation as deem fit it proper.
