(Eligibility Percentile of Post Basic B.Sc. Nursing Entrance Examination, 2025)

The result of Entrance Examination for admission into Post Basic B.Sc. Nursing course in the Institutes of Assam conducted by Srimanta Sankaradeva University of Health Sciences on 20-07-2025 is declared and made available in the University website www.ssuhs.in

Candidates are requested to download their score cards by logging into the application portal available in the University website using Login ID and Password created at the time of submission of application form.

Date of counselling for admission shall be notified by the concerned authorities in due course of time. **All the eligible in-service candidates are directed to obtain Study Leave Permission from the Govt. of Assam / designated Employer for submission during counselling.**

Further, in pursuance of Assam Govt. Notification No.e.MER.488929/19, dated 26-07-2024, SSUHS is pleased to notify the following minimum eligibility percentile and corresponding marks in the Entrance Examination for admission into Post Basic B.Sc. Nursing course for academic session 2025-26.

(1) For 50% Management Quota Seats in Private Institutes:

| Divyang | 15 th Percentile = 36 marks |

All the Institutes/ Colleges of Assam running Post Basic B.Sc. Nursing course are to admit students for academic session 2025-26 in accordance with the above norms. **The Institutes admitting in-service candidates are hereby directed to collect and submit valid No Objection Certificate / Study Leave Permission from the appropriate appointing authority to the University within 30(thirty) days of admission. The University shall get the No Objection Certificate / Study Leave Permission verified by the issuing authority.**

Non-compliance of the above, if detected at any stage, shall invite serious legal consequences as per University norms.
